REGULAR MEETING July 11, 2012 APPROVED MINUTES

- 1. The regular meeting of the Wild Rice Watershed District Board of Managers was held on Wednesday, July 11, 2012. Managers in attendance included Greg Holmvik, Duane Erickson, Raymond Hanson, John Austinson, Mike Christensen, Dean Spaeth and Curt Johannsen. Absent: None. In addition the following persons were in attendance: Administrator Kevin Ruud, Loretta Johnson, Engineer Jerry Bents, Attorney Hanson and various other interested taxpayers and landowners.
- 2. Chairman Holmvik called the meeting to order 8:30 a.m.
- 3. <u>Agenda Approval</u>. A motion was made by Manager Hanson and seconded by Manager Christensen to approve the agenda with the addition of removing the June 27 minutes, addition of Moccasin Creek, Beaver Control, Clay County Ditch #1 FEMA repair and the request for a special meeting on Thursday July 26, 2012. Carried.
- 4. <u>Approval of Billings</u>. A motion was made by Manager Austinson and seconded by Manager Hanson to approve the bills as distributed. Carried.
- 5. <u>Meeting Minutes</u>. A motion was made by Manager Johannsen and seconded by Manager Christensen to approve the Regular Meeting Minutes dated June 13, 2012, with the following changes: paragraph #16, the Managers will review each request; paragraph #32, Manager Erickson opposed. Carried.
- 6. <u>Draft Financial Report</u>. A draft financial report dated April 30, 2012, was distributed to Board members for review. Financial Reports for Board action will be provided to the Board upon completion of the District's audit, which is expected soon.
- 7. <u>Beaver Control</u>. Managers discussed various options for beaver control, including paying possible bounty. No decision was made.
- 8. <u>Chris Ellison-Wild Rice River Sediment Study</u>. Chris Ellison, USGS Hydrologist, gave a report to the board on a sediment study conducted on the Wild Rice River. Engineer Bents commented that the data given may be used in the future if the District does projects to determine the aggradation and future maintenance of a project.

PERMIT APPLICATIONS

9. Mark Chisholm, Section 1, Green Meadow Twp. A motion was made by Manager Hanson and seconded by Manager Spaeth to deny #7-11-12-9 to replace a 48" centerline culvert with a Texas crossing or add more culverts due to concerns of downstream impacts. Carried.

VIOLATIONS

10. Jerome Thompson and David Kitchell filed a complaint against Mark Habedank alleging that he lowered a county ditch and blocked the natural waterway with a berm in Section 1/6 of Lake Ida Township. The Board decided to break the complaints into two parts. A motion was made by Manager Austinson and seconded by Manager Hanson to determine that the cleaning is not a violation of District rules. Carried.

A motion was made by Manager Austinson and seconded by Manager Hanson to declare the berm as a violation and determination made that the berm must be restored to its original condition or file for an after the fact permit. Carried. Correspondence will be mailed out to the affected parties.

 - Ronald Mickelson, Section 31, McDonaldsville Twp. Construct a farmstead ring dike.
 - Doug Nelson, Section 29, Pleasant View Twp. Install subsurface drain tile.
 - Brad Olek, Section 33, Felton Twp. Install subsurface drain tile.

 - Wild Rice Township. Section 32, Wild Rice Twp. Remove a driveway, install a new field approach, install a new center line culvert, install a depressed culvert.
- 12. A motion was made by Manager Spaeth and seconded by Manager Hanson to approve the following permit applications with conditions as listed. Carried.
 - Chuck Borgen, Section 32, Hegne Twp. Permit #7-11-12-5 to install subsurface drain tile with the following recommendations and conditions: 1. Recommendation that the applicant contact and coordinate with the NRCS/SWCD/FSA offices to ensure approval/clearance regarding any potential wetland issues (and with the USFW for installation of tile on any parcel that is under easement from the USFWS). 2. Recommendation that the applicant obtain approval from the necessary road authorities (Township, county, state,...) for any work in the road R/W and the drainage authorities (county) for outlets into legal ditches not under the WRWD jurisdiction. 3. Approved with the condition that the applicant is responsible for adequate erosion control measures at the outlet of the tile system. This should include the installation of riprap or other protection measures at pump outlets. It will remain the responsibility of the applicant to maintain this protection as long as the tile is in place and operating. 4. Approved with the condition that all gravity outlets be installed above (however not more than 2-feet above) the elevation of the original design gradeline of the receiving ditch or channel. 5. Pumped Outlets Only – Approved with the condition that the pump (s) not be operated during freezing conditions and during times of downstream flooding and that pumps and associated pipes will not be installed above ground and will not block vehicle traffic on the ROW of ditch systems. Also all disturbed areas in the ditch ROW's will be restored and reseeded to preexisting conditions.

- <u>Chuck Borgen, Section 33, Hegne Twp</u>. Permit #7-11-12-6 to install subsurface drain tile with the recommendations and conditions listed in 7-11-12-5.
- <u>Chuck Borgen, Section 18, Felton Twp</u>. Permit #7-11-12-7 to install subsurface drain tile with the recommendations and conditions listed in 7-11-12-5.
- <u>Aaron Broden, Section 2, Lockhart Twp</u>. Permit #7-11-12-8 to install a field approach and a 36" pipe.
- <u>John Jossund, Section 32, Lee Twp</u>. Permit #7-11-12-13 to replace an 18" culvert with a longer one, is approved with the condition that the culvert will be installed at the same elevation and location as the existing one.
- <u>Liebl AG LLC</u>, <u>Section 9</u>, <u>McDonaldsville Twp</u>. Permit #7-11-12-14 to install a driveway and an 18" culvert.
- <u>Loretel Systems, Section 13, Pleasant View Twp</u>. Permit #7-11-12-15 to install fiber optic cable under Project #30 with the condition that the cable line is installed a minimum of 30" below any ditch channel bottoms and the applicant is responsible for adequate erosion control measures during construction.
- <u>Gray Schlick, Section 15, Rosedale Twp.</u> Permit #7-11-12-22 to construct water and sediment basins.
- 13. Chuck Borgen, Section 25, Georgetown Twp. A motion was made by Manager Austinson and seconded by Manager Hanson to approve Permit #7-11-12-4 to install subsurface drain tile with the following conditions and recommendations: 1. Recommendation that the applicant contact and coordinate with the NRCS/SWCD/FSA offices to ensure approval/clearance regarding any potential wetland issues (and with the USFW for installation of tile on any parcel that is under easement from the USFWS). 2. Recommendation that the applicant obtain approval from the necessary road authorities (Township, county, state,...) for any work in the road R/W and the drainage authorities (county) for outlets into legal ditches not under the WRWD jurisdiction. 3. Approved with the condition that the applicant is responsible for adequate erosion control measures at the outlet of the tile system. This should include the installation of riprap or other protection measures at pump outlets. It will remain the responsibility of the applicant to maintain this protection as long as the tile is in place and operating. 4. Approved with the condition that all gravity outlets be installed above (however not more than 2-feet above) the elevation of the original design gradeline of the receiving ditch or channel. 5. Pumped Outlets Only - Approved with the condition that the pump (s) not be operated during freezing conditions and during times of downstream flooding and that pumps and associated pipes will not be installed above ground and will not block vehicle traffic on the ROW of ditch systems. Also all disturbed areas in the ditch ROW's will be restored and reseeded to preexisting conditions. Carried.
- 14. <u>Skaurud Grain Farms</u>, <u>Sections 34, 35 Waukon Twp</u>. A motion was made by Manager Erickson and seconded by Manager Hanson to approve Permit #7-11-12-23 to install subsurface drain tile with the same conditions and recommendations as shown in #7-11-12-4. Carried.

VIOLATIONS

15. <u>John Brandt Violation</u>, <u>Section 21</u>, <u>Green Meadow Twp</u>. A motion was made by Manager Christensen and seconded by Manager Johannsen authorizing staff to notify John Brandt that he must get grass established on the violation prior to October 1, 2012, or the District will hire someone to do it and bill him. Carried.

- 16. Managers discussed the Bob Brandt complaint against Cory Jacobson in Section 10, McDonaldsville Twp. Administrator Ruud reported that the County Board has this as an agenda item on the 19th of July. Ruud also stated that he will contact Nepstad Farms regarding work done in Section 27, Hegne Twp. on Norman County Ditch #36.
- 17. <u>Gerald Chisholm, Section 12, Green Meadow Twp</u>. A motion was made by Manager Spaeth and seconded by Manager Hanson authorizing staff to notify Chisholm that he must either restore the work done in Section 12 to its original condition or apply for an after the fact permit. Carried.
- 18. <u>Community Flood Control Projects</u>. A motion was made by Manager Johannsen and seconded by Manager Christensen to authorize Change Order in the amount of \$13,491.91 and Pay Request to Zavoral in the amount of \$2,883.25 for the Perley Project. Carried. A motion was made by Manager Christensen and seconded by Manager Erickson to approve Change Order in the amount of \$17,809.82 for the Hendrum Project. Carried with Manager Hanson opposed.
- 19. <u>Project #30 FEMA Repair</u>. A motion was made by Manager Spaeth and seconded by Manager Johannsen to approve Change Order in the amount of \$11,160 and Pay Request to Zavoral in the amount of \$185,190 for Project #30. Carried.
- 20. Manager Hanson left the meeting at 11:00 a.m.
- 21. <u>Project #1, Norman County Ditch #1 FEMA Repair</u>. A motion was made by Manager Spaeth and seconded by Manager Christensen authorizing Administrator Ruud and Engineer Bents to acquire permanent and temporary ROW along the area for the project. Carried. A motion was made by Manager Christensen and seconded by Manager Johannsen authorizing Engineer Bents to advertise for contractors for the project repair. Carried.
- 22. <u>Acquisition Leasing</u>. A motion was made by Manager Johannsen and seconded by Manager Austinson to table the request by Wayne Underlee to lease the former John Johnson property in Section 7, Hendrum Twp. until the August meeting. Carried with Manager Erickson opposed. A motion was made by Manager Christensen and seconded by Manager Erickson to table the request by Aaron and Trisha Tank to lease the former Wagner property that the District owns as a result of an acquisition along the Wild Rice River and notify neighboring landowners. Carried.
- 23. <u>2009 Rural Acquisition Demolition</u>. A motion was made by Manager Johannsen and seconded by Manager Christensen to approve Pay Request in the amount of \$16,551.44 to Feldt for demolition of 2009 Rural Acquisition Projects. Carried.
- 24. <u>Clay County Ditch #4 FEMA Repair</u>. A motion was made by Manager Christensen and seconded by Manager Johannsen authorizing the pay request of Gordon Construction in the amount of \$43,955.55 to Gordon Construction for repair of Project #4. Carried.
- 25. <u>Moccasin Creek O & M Plan</u>. Administrator Ruud distributed information for board review regarding the COE's additional information that is necessary prior to a change in the O & M Plan. Ruud stated that to provide this information, there would be costs involved. This will be a topic of discussion at the Project Team meeting scheduled for the 25th of July.

- 26. <u>Special Meeting</u>. Managers were reminded of a special meeting that will be held on July 26, 2012, at the District office to act on permits and discussion with Ron Harnack, Charlie Anderson, Henry VanOffelen and Chuck Fritz regarding the basin assessment of flood control in the District.
- 27. There being no further business to come before the Board of Managers, a motion was made by Manager Spaeth and seconded by Manager Erickson to adjourn the meeting. Carried. Chairman Holmvik adjourned the meeting at 11:30 a.m.
